**Please Read & INITIAL each item below & then Read and SIGN the second page**

\_\_\_\_\_ *All adult CATS must have a current FVRCP & Rabies Vaccination, Be Spayed or Neutered, Wormed, Flea treatment & microchipped (W2W can microchip onsite). Cats must be strictly indoors for at least 14 consecutive days before bringing them to an adoption event. Documentation must be provided. Kittens may be brought in if 8-10 weeks old and have had at least 1 FVRCP shot*

\_\_\_\_\_ **Fosters may not leave animals for adoption until all paperwork is complete and the animals have been examined.**

\_\_\_\_\_ ***PLEASE NOTE--An optional home visit may be performed before granting final foster approval.***

\_\_\_\_\_ **All original profiles, veterinary records, photos, etc. *must* remain with Wags to Whiskers of Texas. Copies as applicable will be provided when the cat is adopted. A separate cat profile **Must** be provided for each cat. incomplete or missing documentation, (including a color photo of each cat), will result in refusal to present your animal for adoption at the discretion of Wags to Whiskers of Texas.**

\_\_\_\_\_ **Home care, feeding, Veterinary care, vaccines, flea treatment and spay/neuter are the responsibility of the Foster. Foster agrees to take cats back that are returned unless special arrangements are made with W2W. Expenses associated with foster care are tax deductible.**

\_\_\_\_\_ **>>VERY IMPORTANT<<Fosters must notify Wags to Whiskers of Texas if the animal is privately adopted out, or you decide to adopt them. Please obtain the adopters name, address, & phone so we can update our records & transfer microchip information to the adopter. Wags to Whiskers of Texas depends on donations to remain operational. The number of adoptions are critical to qualifying for corporate donations and is also required for nonprofit tax information. Please help us when you do a private adoption by agreeing to this requirement.**

Fosters must call or text 713-504-7838 by 3 PM Thursday of each week to reserve kennels. Animals brought in without a reservation may be refused.

**Fosters, Volunteers & Counselors are strictly prohibited from paying or offering to pay adoption fees for potential adopters.**

**Please refrain from redirecting a potential adopter's attention to your cats when they are interested in another fosters cat! Failure to comply may result in your removal from the foster program.**

**Fosters are encouraged to participate in one or more of these tasks. The setup and breakdown of tables, kennels etc., Assisting with the adoption process and chores during the event. Fosters may pick and choose the days they can participate. It is not **REQUIRED** to help, but greatly appreciated.**
